That was the first time I participated in an official capacity in an organization. At that time I joined the Episcopal Peace Fellowship which started by engagement with social justice issues. At that time there were many community issues in Raleigh but two national issues of concern to many - Apartheid in South Africa and Palestine. Demonstrating against Apartheid was a first for me.

Fast forward to New York City 2009 where I had become an advocate for Single Payer Health Care and met the New York Raging Grannies. Singing about all the issues moved me in directions I could not have imagined. All the issues become important when you learn about them through song and sing those words.

Whether I am successful at this election or not I plan to continue some research I have started as I remember hearing that somehow WILPF was involved in starting the Raging Grannies so that is on my to do list for the coming year. There is no longer an active branch here and I do believe there should be one so I will do my best to move this along.

- 1. Ms. Julie's exceptional organization and communications skills: anytime you see Ms. Julie she will have a folder in her hand with artifacts, documents, and printouts of emails that pertain to the matter that she is participating in. Her decades spent as a legal secretary means that she is always organizing her work as part of a larger strategy and fully present in the moment that she is participating in so that she can ensure that whatever is accomplished in that moment doesn't stop there but continues growing and gathering momentum after the fact.
- 2. Ms. Julie is both very active in direct actions and organizing as well as a strategic thinker: in any given week, she might be attending protests, conferences, and meetings in 3 different cities. Most people who are this active might not have the capacity to think long-term and strategically. That is not the case with Ms. Julie I often seek her advice and input on things I am working on and cherish her strength in being able to place the particular immediate action into a long-term trajectory that gives it more meaning.
- 3. While she has only been officially a member of WILPF for 2 years she has been attending meetings for over a decade and has deep institutional knowledge of the Peace-Growing space and a large, varied network of many people who respect her deeply. I am particularly interested in seeing how Ms. Julie can use this institutional knowledge and her participation in the New York City Branch before it was sunsetted.
