help encourage other women of color or women from diverse backgrounds in future to apply for leadership roles within WILPF.

I also believe that its important for someone like myself who has been a WILPF member for a long time and having witnessed the challenges that we face today, that I offer my experience, skills, ability and most importantly, my love and passion for what WILPF has stood for so many decades.

4. Please describe your other non-WILPF work or involvement that you believe helps qualify you for this position:

I Serve on the advisory board of our nations largest coalition of activists and legal professionals working the issues of "Human Trafficking" called the FNUSA (Freedom network USA). As an advisory board member, I get to closely and directly interact with both the victims and hear personal stories that help me understand the issue of human migration as well as border crises in more in-depth manner. I also see how these issues are intricately linked with so many other issues such as racism, poverty and war, all of which are issues that WILPF has been working on for many decades. Additionally, I serve within my local community as a member of our local public library and that helps me appreciate the value and importance of knowledge and resources that our public libraries provide so that our communities are better informed as well as have access to other resources such as the internet and computers. knowledge is power and better informed communities are an asset to society at large.

Candidate Statement

I grew up in India and was raised in a family of social and political activists who were at the forefront of the freedom struggle of India against the colonization of British rule.

It was in India that I was first introduced to WILPF, during one of its International Congresses held in 2009. The congress was held at the WILPF-India, headquarters in Gujarat Vidyapeeth, a University that was founded in 1923 by Mahatma-Gandhi.

This was the first time where I met and heard from some absolutely outstanding WILPFwomen from across the world who spoke about their work as well as what WILPF did internationally through its various sections and it opened my eyes to this organization.

I came back hugely impressed by its history and legacy and soon found myself becoming its active member, initiating a start up of an all youth WILPF-branch in the city of my birth in Delhi-India.

Few years later, I migrated to the US because of personal and family reasons and was thrilled to discover the US section actively engaged in the global work of WILPF.

Since 2014, I have been an active member of WILPF-US. Over the years, I have served in several of our national standing and ad-hoc committees, including my service as the Membership Chair on our national board.

The work of peace building is not easy, however, as we continue to be faced with the uphill task of feminist peace building process, it's so important that WILPF not only remains relevant and sustainable organizationally, but also gets much needed strategic and forward looking vision, renewed energy and momentum to carry forward the mantle of our foremothers.

As a senior management professional who has held leadership roles for several international government and trans-national corporations and as a young woman of color actively pursuing a career in information systems at present, I believe that I bring a unique perspective to the table.

Additionally, at a time when we in WILPF-US are planning to hire an executive director and bring on board a team of professionals as part of our Lloyd Legacy initiative, it is imperative that we prepare to provide such professionals a structure and professional environment that will support them in successfully accomplishing their goals.

I believe that Martha Collins and myself as co-presidents will be able to provide the needed leadership as we march forward together as an organization.

Activist Bio

I hold a Master's in Business Administration with dual concentrations in Management Information Systems and Human Resources Management. I have over 15 years of experience working in the areas of project management, change management, instructional design, training and development.

Over the years, I have transitioned from non-profit management to leading information technology based projects.

I started my career with Dell Computers as senior technical trainer and transitioned to the field of adult training and development during my time as a consultant to the United Nations Development Program (UNDP) in India. During this time, I worked on developing training manuals, advocacy and outreach materials on several topics ranging from peaceful conflict resolution, to mediation, to gender based violence and volunteering skills for the development of sustainable development goals (formerly known as the millennium development goals). Over the weekends, I use to work with the national TV network in India and created and presented media reports on social and development related events in the city (see link below). I was also interviewed live by the national TV network in recognition of my work as a young leader working on the MDG's.

Since migrating to the US, I have worked as an instructional designer and training consultant for one of the leading companies providing consulting services to the US government. For the last few years, I am working as a department head for information systems.

I also continue to actively engage as a volunteer, with several local community groups on issues of climate change, human trafficking and migration.

the rest of the world views the area, and US policies. This has shaped my activist work.

Shilpa's background within WILPF and in her career give her the skills needed to lead WILPF US at this time. Shilpa worked as a consultant with the United Nations Development Program in India. Her journey with WILPF began at this time. She initiated an all youth branch and served on the Board of WILPF India as its youngest board member. Since immigrating to the US, Shilpa has served on the WILPF US Board as Membership Chair 2016-2022 and since 2021 has led the UN Practicum. Because of her familiarity with the UN and its agencies she could mentor the participants and anticipate what they need as they develop their careers. Shilpa's own career over the last ten years has been in senior management where she led large teams of professionals at multinational and international organizations. She holds an MBA with dual concentrations in human resource management and information systems.

During the nearly 20 years that WILPF US has operated without an Executive Director, the role of the non-profit Executive Director has evolved considerably. We hope to hire an ED early next year for a job that is now highly professional and operates in the current information and fundraising environments. Shilpa Pandey and Martha Collins understand these issues from their work experiences - Shilpa in information systems and management, and Martha Collins in fund development and nonprofit advocacy.
