Candidate's Statement

Thank you for the opportunity to apply for a position on the Board of WILPF US as Personnel Committee Chair. I have only been a member of WILPF US for a little over two years. However, I feel as if this position is tailored to the reason that I majored in Leadership and Organizational Communication for my Bachelor's Degree. In pursuing this degree, it was very important to me to see valuable people who are experiencing challenges in life not be excluded from participating- whether it be in employment or in other areas. Too often, factors that impact our contributions are disregarded with a "hard line stance"... meaning that if one is experiencing mental health challenges, recovering from grief (which can often last longer than 2 weeks), have small children in the household and find oneself struggling with child care matters- or perhaps economic circumstances play into things..such as not being able to afford connectivity or transportation. A balance must be had between the needs of the organization and valuing those who are giving their best towards the aims of an organization.

In WILPF, there are a small number of people who are filling many roles. Some are volunteers, some are paid, some are paid and volunteer elsewhere. Being treated with fairness and respect within the guidelines of an organization results in higher productivity from employees. This has been proven by many scholars in the Organizational Communication field.

It is necessary for personnel to adhere to standards in order for an organization to function successfully. We also must respect the fact that most people want to perform at their highest potential. A good Personnel Committee chair will assist in this area with good communication and systems of support when our valued personnel require them.
